- I. Call to Order and Determination of a Quorum
 The meeting was called to order at 10:30 a.m., Thursday, March 20, 2025.
- II. Proof of Posting of notice in accordance with Chapter 551, Texas Government Code, as amended, known as the Texas Open Meetings Act.

Proof of posting of the March 20, 2025 Executive Committee meeting was provided by Mary McDow.

- III. Introduction of Guests Guests and staff were introduced.
- IV. Consideration of and/or action on the following:
 - A. Approval of the February 27, 2025 meeting minutes A motion was made by Judge Jay Elliott and seconded by Judge Scott Felton to approve the February 27, 2025 meeting minutes as presented. Motion passed.
 - B. New Business
 - 1. TexPool Resolution Amending Authorized Representatives

Ms. Michelle Vasquez stated the resolution presented is to amend the authorized representatives who can authorize and transmit funds for investment in TexPool. As Director of Finance and Administration, Michelle Vasquez will have primary responsibility for performing transactions and receiving confirmations and monthly statements under the Participation Agreement.

A motion was made by Judge Jay Elliott and seconded by Judge Linda Grant to adopt the attached Resolution Amending Authorized Representatives as presented. Motion passed.

2. Authorization of Purchase of Communications Equipment from Nalcom Wireless Communication

Mr. Harold Ferguson stated that HOTCOG has received funding from the Statewide Emergency Radio Infrastructure (SERI) grant to purchase Tait radio repeaters/voters, corresponding radio equipment, and installation as upgrades for the current outdated Tait technology. This equipment will improve the radio infrastructure for Bosque County first responder services. Currently, Nalcom Wireless Communications is the only approved Tait radio vendor for the HOTCOG region and have priced a majority cost of the quote at HGAC procurement contact

pricing.

A motion was made by Judge Cindy Vanlandingham and seconded by Judge Jay Elliott to approve the purchase and installation of radio communication equipment in the amount of \$252,318.61 using the SERI grant for Bosque County. Motion passed.

C. Report of the Executive Director and Staff

1. Department of Administration

a. Financial and Personnel Report

Ms. Vasquez presented the financial and personnel report to the committee.

2. Regional Services

a. Department Activities Report

Mrs. Jackson presented an overview of the Comprehensive Economic Development Strategy (CEDS) document to the committee. Mrs. Jackson noted that as a designated Economic Development District, the Heart of Texas Economic Development District (HOTEDD) is responsible for preparing and adopting a CEDS document at least every five years and approved and adopted by HOTEDD Board of Directors. The CEDS is designed to provide baseline information on demographics and economic data, economic development strategies and implementation plans, and identify potential projects within the region.

3. Health & Human Services

a. Department Activities Report

Mr. John Vorderkunz presented the summary of activities for the programs of the Health and Human Services division including the Area Agency on Aging, the Aging and Disability Resource Center, the Heart of Texas 2-1-1 and the Rural Transit District. Mr. Vorderkunz noted the new Resource Guides are being reviewed and will be printed and ready for distribution in the next few weeks.

Mr. Rep Pledger gave an update on the activities of the Heart of Texas Rural Transportation program.

3. Executive Director's Report

Mr. Devorsky noted that the Commission on State Emergency Communications has conducted its review of the FY2024 9-1-1 program activities for HOTCOG and the compliance review identified the Heart of Texas as being Low Risk. Mr. Devorsky recognized staff members Kristine Hill and Sarah Wines for their hard work to provide quality 9-1-1 services in the rural counties.

Mr. Devorsky discussed the Long Term Care (LTC) Ombudsman program and the importance of the legislators to support and advocate for increased funding annually. These funds will go to the 28 Area Agencies on Aging that house a local ombudsman office. The funds will pay for additional travel, training, and related

staff expenses. The funds will support a local ombudsman's ability to protect residents in the communities they serve. Currently, Texas has a ratio of one ombudsman to 2,511 residents and the recommendation is a ratio of one ombudsman to 2,000 residents.

REGIIONAL SERVICES REPORT

April-May 2025

9-1-1

HOTCOG 9-1-1 IP Network (Next-Generation 9-1-1)

Members of the TriCOG 9-1-1 Alliance (BVCOG, CTCOG and HOTCOG) continue to collaborate with network consultants and equipment vendors to maintain a robust network. The TriCOG Alliance maintains its partnership with Mission Critical Partners (MCP) for NextGen Core Services (NGCS) Consulting and Cybersecurity Support. MCP follows a scope of work identifying three tasks to assist the TriCOG in technical issues to include Project/Task Management for GIS Readiness and Geospatial Call Routing, Procurement support for a Request for Proposal for call handling equipment and the development of a Cyber Security Plan. Members of the TriCOG participate in regularly scheduled conference calls to discuss ongoing NGCS projects and planning for the future of the regional networks. In addition, project planning calls with Motorola Solutions Connectivity, Inc. continue to be held weekly, and discussions include ongoing project deliverables and discussions for upcoming activities.

Enterprise Geospatial Database Management System (EGDMS)

In NG9-1-1 systems, an EGDMS (GIS map data) replaces the traditional Master Street Address Guide (MSAG) for location-based 9-1-1 call routing and location validation. An EGDMS is crucial for the transition to NG9-1-1 because it provides a means to create and maintain data critical to NG9-1-1 success. Staff participated in the Customer Focus Group (CFG) for this project. The CFG was responsible for assisting with the development of the Quality Assurance/Quality Control plan, participating in GIS Data Management collaboration meetings, and assisting in GIS data management workflow development.

9-1-1 staff exceeded the 99% data match rate as recommended by the National Emergency Number Association (NENA) with a match rate of 99.99% with no critical errors remaining. HOTCOG has completed the transition to an EGDMS, and staff participants on a focus group for continued implementation across the state.

Text-to-9-1-1

Text-to-9-1-1 is available in the HOTCOG Region as an alternate means of communicating with 9-1-1 for people with a hearing and/or speech disability, or when speaking aloud would put the individual in danger. Text-to-9-1-1 also provides a silent alternative in cases such as child abduction, active shooter, or domestic abuse.

National Public Safety Telecommunicators Week (NPSTW)

Every year during the second full week of April, telecommunications personnel in the public safety community are honored. This year during National Public Safety Telecommunications Week, April 13-19th, HOTCOG staff presented beach towels and solar chargers to the regions Public Safety Answering Point (PSAP) staff to recognize and thank them for their dedication in protecting and serving our communities. The items were imprinted with the message, "9-1-1, You Make a Difference."

Homeland Security/Emergency Preparedness

Grant/COG Projects

- o Staff is working on communications tower projects for bi-annual State Emergency Radio Infrastructure Program in Hill and Bosque Counties.
- o Staff is procuring (2) new Backup Generators for the Falls County Communications Tower sites in Lott and Reagan. One of these generators has failed and the other which is near the same age is being replaced as a precautionary measure at a cost of approximately \$35,000. Also both the Dispatch Radio Consoles at the Falls County Sheriff's Office went down and were needing replaced. The Consoles were replaced along with Battery Backup Systems and a new Computer Aided Dispatch Program at a cost of Approximately \$46,000. Staff was able to fund both these projects through left over funds from the 2023-2024 SERI Communications Grant.

Technical Assistance

- o HOTCOG staff attended the Office of the Governor-Public Safety Office Conference Call.
- o The Emergency Preparedness Advisory Committee Meeting was held.
- o Staff developed and coordinated a Regional Emergency Preparedness Tabletop Exercise for local first Responders to assess the region's capabilities and needs in the event of an actual event. Much was learned and more exercises are going to be planned in the future.

Criminal Justice

Planning Grant

Lana continues updating the 2025 Strategic plans for the region.

SART - the Heart of Texas Sexual Assault Response Team subcommittee formations have begun the subcommittees Lana met with Marlin Police Department regarding the SART member appointment for Falls County SART.

State Crisis Intervention Grant Program – HOTCOG was awarded \$20,898.61 for the development of a Heart of Texas Regional Crisis Intervention Team. The second team meeting was rescheduled to May 28th due to a power outage. Lana scheduled the first training for the CIT for July 28-Aug 1, 2025.

Regional Law Enforcement Training Academy Grant

Lana continued working on the training schedule for FY 2025. Lana was able to add two new mandated ALERRT I classes to the schedule in May and July in Falls County.

BMMAP

Lana has been in contact with several agencies regarding BMAP in FY 2025 training for the BMAP program is set to begin in May. Lana contracted with New Mexico Tech to bring the Homemade Explosives: Awareness, Recognition and Response training to Waco in August. This training is free for all first responders.

311 students attended HOTCOG training, totaling 7684 contact training hours since November 2023.

Economic & Community Development Department

Revolving Loan Fund

USDA Fund:

- Purpose: Support local businesses for growth, job creation, and regional economic diversification.
- Target: Small and emerging businesses in rural areas of Bosque, Falls, Freestone, Hill, Limestone, and rural McLennan Counties.
- Criteria:
 - Private businesses employing 50 or fewer new employees.
 - o Projected gross revenues of less than \$1 million.
 - Preference for businesses in specified rural counties, though exceptions may be made for businesses outside the region with a positive economic impact.
 - Job creation or retention requirement: One full-time job per \$10,000 in loan funding.

- Ownership: 51% interest in the business must be by U.S. citizens or legal permanent residents.
- Financial necessity: Evidence required that project needs cannot be met by owner resources or commercial financial institutions.
- Available Funds: \$247,691.00

U.S. Economic Development News:

Federal Budget Update: Impacts on Regional Economic Development Programs

Recent developments in the federal discretionary budget have introduced significant proposed changes that could impact key economic development initiatives in our region. These changes are part of the President's budget proposal and are subject to Congressional review and potential revision. Notably, two programs central to our economic development efforts—the Economic Development Administration (EDA) and Community Development Block Grants (CDBG)—are facing substantial cuts and restructuring.

Reauthorization of the EDA

On January 4, 2025, the U.S. Congress reauthorized the Economic Development Administration for the first time in two decades through the **Thomas R. Carper Water Resources Development Act of 2024 (S. 4367)**. The bipartisan legislation strengthens EDA's foundational programs and supports the agency's long-standing mission under the Public Works and Economic Development Act of 1965. This reauthorization enhances the EDA's ability to support regional economic initiatives and is a positive development for Economic Development Districts nationwide.

Proposed Budget Cuts and Justifications

Despite the reauthorization, the federal budget proposal recommends **significant funding rescissions and the potential elimination of the EDA**, "citing concerns about program misuse and ideological agendas. The proposal characterizes EDA activities as political earmarks or vehicles for equity and climate-related efforts, referencing examples outside our region such as the National Comedy Center hologram project and Portland's Pride Plaza."

Locally, the EDA has supported impactful and well-vetted projects, including:

- Industrial park upgrades in the City of Mexia
- · Road enhancements to the Sherwin Williams facility in Bellmead
- Infrastructure improvements at the City of Fairfield industrial park
- Workforce development expansions at Texas State Technical College (TSTC)

These projects have demonstrated strong alignment with regional economic goals and provide tangible returns on investment for our communities.

Community Development Block Grant (CDBG) Impacts

The proposed budget also targets the elimination of the Community Services Block Grant and CDBG funding, directly affecting vital grant programs that benefit rural and underserved communities. This includes grants administered by the Texas Department of Agriculture (TDA) and Hazard Mitigation funds managed through other federal and state agencies.

Of particular concern, the TDA's **biennium grant cycles**—which typically fund **4 to 6 communities with \$500,000 grants each**—would be entirely eliminated. These grants support critical infrastructure improvements, public facility upgrades, and essential community development initiatives. Additionally, the proposed cuts jeopardize matching funds and leverage opportunities for hazard mitigation and resilience projects coordinated with FEMA and related agencies.

The elimination of these funds would significantly reduce the capacity of local governments to respond to economic, environmental, and public health challenges.

Given the potential ramifications of these proposals, local leaders-are strongly encouraged to **contact their Congressional representatives** to advocate for the continuation of EDA and CDBG funding. These programs have a long-standing history of delivering results and enabling small and rural communities to thrive through targeted economic and infrastructure investments.

EDA's Reauthorization

The reauthorization of the Economic Development Administration (EDA) strengthens its role in economic development, job creation, disaster recovery, and infrastructure investment. The following are the key benefits of this legislative update:

1. Strengthening Tools to Support EDA's Role in Job Creation and Workforce Development

- Industry-Led Workforce Training Partnerships Codifies EDA's role in fostering workforce training initiatives that invest in innovative workforce development approaches, ensuring job opportunities for American workers.
- Alignment with Department of Commerce Priorities Enhances EDA's ability to support critical economic priorities, including:
 - Supply Chain and Manufacturing Incorporates elements of *The ONSHORE Act* to facilitate site development for industries with national security implications.
 - Broadband Expansion Modernizes EDA's capacity to implement broadband infrastructure projects through provisions of the E-BRIDGE Act.

2. Modernizing EDA's Authorities for Critical Grants and Resource Delivery

- Office of Disaster Recovery and Resilience Establishes a dedicated office within EDA to coordinate federal support for regional disaster recovery efforts. This office will leverage EDA's existing network of Economic Development Districts (EDDs), University Centers, and other key stakeholders.
- Enhanced Grantmaking Eligibility Criteria Expands and updates eligibility considerations, allowing for the use of additional statistical factors to support grant allocation and economic development strategies.

3. Improving EDA Operational Efficiency and Transparency

- Pre-Development Assistance for Distressed Communities Codifies a formal definition of "pre-development," enabling EDA to provide assistance to economically distressed areas in preparing for large-scale infrastructure investments.
- **Permanent Disaster Hiring Authority** Ensures EDA can quickly mobilize and respond to future disasters by permanently authorizing its disaster hiring capabilities.
- Strengthened Regional Collaboration Formalizes the relationship between EDA and Regional Commissions to improve the coordination and effectiveness of regional economic development programs.

Legislative Context

EDA's reauthorization is a critical component of the *Thomas R. Carper Water Resources Development Act of 2024*, which passed with bipartisan support in Congress. This legislative update enhances EDA's ability to foster economic resilience, infrastructure modernization, and workforce development nationwide.

This reauthorization strengthens EDA's role in driving economic growth and ensuring that communities—particularly those facing economic distress or disaster impacts—have the necessary tools and resources for long-term prosperity.

Key Economic Development Investments Supported by EDA

The Economic Development Administration (EDA) continues to play a crucial role in fostering economic growth, job creation, and infrastructure development. The following priority investment areas illustrate EDA's commitment to supporting communities through strategic economic initiatives:

Infrastructure and Facility Development

- **Technology-Based Facilities** Supporting innovation and research hubs to drive economic advancement.
- Multi-Tenant Manufacturing Facilities Enabling flexible manufacturing spaces that enhance industrial productivity.
- Business and Industrial Parks Facilitating the development of business clusters and regional economic hubs.
- Telecommunication and Development Facilities Expanding broadband and communication infrastructure to strengthen connectivity.
- Water and Sewer System Improvements Enhancing critical infrastructure to support sustainable economic growth.

Business and Workforce Development

- Business Incubator Facilities Providing early-stage businesses with essential resources and support.
- **Port and Harbor Expansions** Strengthening trade and logistics infrastructure to enhance regional commerce.
- **Skill-Training Facilities** Investing in workforce training programs to meet evolving industry demands.
- **Brownfield Redevelopment** Restoring and repurposing underutilized or contaminated sites for economic use.

These investments reflect EDA's focus on fostering resilient, innovation-driven, and inclusive economic development across regions. By strategically aligning resources with community needs, EDA continues to enhance economic opportunities and regional competitiveness.

New Priorities:

EDA's investment priorities provide an overarching framework to ensure its grant investment portfolio – ranging from planning to infrastructure construction -- contributes to local efforts to build, improve, or better leverage economic assets that allow businesses to succeed and regional economies to prosper and become more resilient. Competitive grant applications will be responsive to the evaluation criteria listed under each individual funding announcement, including at least one of the below investment priorities.

- 1. **Critical Infrastructure:** Economic development planning or implementation projects that support development of public facilities, including basic public infrastructure, transportation infrastructure, or telecommunications infrastructure.
- 2. Workforce: Economic Development planning or implementation projects that
 - a. Support job skills training to meet the hiring needs of the area in which the project is to be carried out and that result in well-paying jobs; or
 - b. Otherwise promote labor force participation.
- 3. **Innovation and Entrepreneurship:** Economic development planning or implementation projects that
 - a. Support the development of innovation and entrepreneurship-related infrastructure;
 - b. Promote business development and lending; or
 - c. Foster the commercialization of new technologies that are creating technology-driven businesses and high-skilled, well-paying jobs of the future.
- 4. Economic Recovery Resilience: Economic development planning or implementation projects that enhance the ability of an area to withstand and recover from adverse short-term or long-term changes in economic conditions, including effects from industry contractions or economic impacts from natural disasters.
- 5. **Manufacturing:** Economic development planning or implementation projects that encourage job creation, business expansion, technology and capital upgrades, and productivity growth in manufacturing, including efforts that contribute to the competitiveness and growth of domestic suppliers or the domestic production of innovative, high-value products and production technologies.

U.S. Economic Development Administration Grants

FY 2023 PWEAA Application Submission and Program Requirements:

The FY 2023 Public Works and Economic Adjustment Assistance (PWEAA) Notice of Funding Opportunity (NOFO) outlines the process for applying to two core EDA programs under the Public Works and Economic Development Act: the Public Works program and the Economic Adjustment Assistance (EAA) program. This NOFO replaces the FY 2020 version and includes updated application requirements.

Key Points:

- Funding Availability: Applications are accepted on a rolling basis until a new NOFO is issued, the current NOFO is canceled, or all available funds are allocated. A recent update adds \$5M specifically for indigenous communities and incorporates regulatory changes (2 CFR 200 updates) for new FY25 awards.
- Program Focus: EDA emphasizes strategies that leverage regional strengths to foster economic growth, support equity, address workforce needs, and improve climate change resilience.
- Review Process: The EDA reviews applications promptly upon receiving complete submissions.

The contact specialists attempt to identify at least 3 resources for each identified need. It is the caller's responsibility to reach out to each agency and provide any additional information requested for consideration for assistance through their program. We always encourage all callers to call us again should they need more resources or identify another need.

From time to time a caller will request assistance with something that unfortunately there is not a resource providing assistance, this becomes an *unmet need*. An example of an *unmet need* would be a request for assistance paying their rent, unfortunately unless you are a disabled Veteran or live in one specific zip code, 76705, there is not an agency that is assisting with rent in our HOTCOG region. Another example of an *unmet need* would be a request for assistance with paying an electric bill. There are several agencies that may be able to assist the caller with paying an electric bill if they meet eligibility criteria AND they have an approved electricity provider such as TXU, Direct Energy or Reliant. Unfortunately, if the caller does not have one of the approved providers there will not be any assistance available, and we will record this as an *unmet need*.

2-1-1 provides referral information about health and human services to all callers regardless of age, ethnicity, gender, disability, or other criteria. 2-1-1 is available 365 days a year and 24 hours a day. 2-1-1 does not provide any funding, only resources to callers for non-profit, social service agencies who have voluntarily become part of our database designed to assist our callers. HTCG 2-1-1 continues to take traditional calls for local social service needs, including food pantries, utility bills, rent, childcare, medication assistance, mental health, and everything from A to Z for the state of Texas, including our six-county service area. In addition, we provide assistance for disaster-related calls when such an event occurs and provide close monitoring and reporting of any resources available for those impacted by the disaster. Disaster support is provided across the state of Texas.

Our goal is to assist with as many resources as the caller needs. We also make sure to ask callers who ultimately need to be transferred to the Health and Human Services Commission (HHSC) for state benefit assistance if there is anything else we can assist them with before transferring them, and quite often they will ask for assistance in one or more areas.

Please help spread the word that 2-1-1 phone assistance is available 24/7 to everyone! All ages, all races, all socioeconomic backgrounds. We have resources from A-Z, and we are here to help. The website www.211texas.org is also available 24/7.


