Lana reviewed the budget for the Law Enforcement Training program for the FY 2024 / 2025 with the current budget program has \$2000.00, remaining all of which is currently obligated to pay for instructors of already scheduled classes. Since the budget is much smaller than in previous years, Lana has partnered with SAFVIC, New Mexico Tech and Texas Police Trainers to bring additional classed to the area that are free. Lana was able to schedule three new courses that are free, the Homemade Explosives, Awareness, Recognition and Response in August, Autism and LE, and SAFVIC Investigator course. These classes are all free for all first responders. The program also hosted two ALERT I classes in Bosques County and hopes to be able to do another class in May. Jerry Wood stated that he would get with his contacts in Falls County to see if he could find a place to host the ALERT class in Falls County.

Lana then announced that HOTCOG was awarded a Crisis Intervention Grant that will be paying for a Crisis Intervention course in July. The Crisis Intervention Grant will be helping to fund a new Crisis Intervention Team in the region, that will be brining additional training for all first responders as well as working with Behavioral Health Network on a new program that is developing a LOSS team that is made up of volunteers to respond to suicide calls and assist with the family members of suicide victims.
