1. Call to Order and Determination of a Quorum

Proof of posting of the May 25, 2023 Executive Committee meeting was provided.

- 2. Introduction of Guests Guests and staff were introduced.
- 3. Consideration of and/or action on the following:
  - A. Approval of the April 27, 2023 meeting minutes

A motion was made by Mayor Geary Smith and seconded by Councilmember Jimmy Rogers to approve the April 27, 2023 meeting minutes as presented. Motion passed.

## B. New Business

1. FY2022 Audit Report, Auditors Communication Letter to those charged with governance and HOTCOG's comments

Mr. John Minnix introduced Mr. Todd Pruitt from Pattillo, Brown & Hill to present the FY2022 Audit Report to the committee. Mr. Pruitt stated that Pattillo, Brown & Hill were engaged to perform a single audit for HOTCOG which includes two separate components, audit of financial statements and a compliance of HOTCOG's federal and state grant awards programs. Mr. Pruitt gave a review of the audit and stated there were no findings or questioned costs.

A motion was made by Judge Scott Felton and seconded by Commissioner Nita Wuebker to approve the FY2022 Audit Report and Auditors Communication Letter to those charged with governance and authorize the Executive Director to forward copies of said reports to the appropriate Federal and State agencies. Motion passed.

2. Computer/Information Technology and Communication Services

Mr. Minnix stated that staff completed the request for proposal (RFP) for Computer/IT and Communication services. Two (2) proposals were received and evaluated by Russell Devorsky, John Minnix and Michelle Vasquez. (Prices are on based on an annual basis.)

Extraco Technologies - Waco, Texas, \$47,356 (currently provides the service) Strattmont Group – Bryan, Texas, \$65,964 plus \$6,397 (initial assessment & setup)

A motion was made by Judge Richard Duncan and seconded by Judge Linda Grant to approve the selection of Extraco Technologies to provide Computer/IT and Communication services for HOTCOG for a three (3) year contract with the option

to renew for two (2) one (1) year terms upon written consent of HOTCOG to begin June 1, 2023. Motion passed.

3. Authorization to contract with Huffman Communications in Corsicana, Texas for replacement of microwave links in Limestone County using the Statewide Radio Infrastructure Grant awarded to HOTCOG

Mr. Wayne Stovall stated that staff requested quotes from local vendors for the replacement of seven microwave links in Limestone County. These links are used for the Law Enforcement and Fire Radio Communications within the county. Mr. Stovall noted that similar projects have replaced microwave links in other counties in the past. Huffman Communications in Corsicana, Texas was the only vendor to submit an acceptable quote of \$177,309.

A motion was made by Judge Duncan and seconded by Mayor Geary Smith to approve and authorize the Executive Director to issue a Purchase Order in the amount not to exceed \$177,309 for the replacement of seven microwave links in Limestone County. Motion passed.

## 4. Heart of Texas Rural Transit District Title VI update

Mr. Russell Devorsky stated that the Heart of Texas Rural Transit District Title VI Plan was updated by staff and has been reviewed and approved by the Texas Department of Transportation with approval period of May 16, 2023 – May 15, 2026. The Title VI Plan is required to be updated every three years. Mr. Devorsky noted the updates to the Title VI plan regarding the civil rights policy include: placing and posting public notices on the HOTCOG website; complaint procedures and complaint form made available in English and Spanish and any other language that is requested.

A motion was made by Freestone County Treasurer Jeannie Keeney and seconded by Waco Councilmember Andrea Barefield to approve the Heart of Texas Council of Governments Transportation Rural Transit District Title VI Plan program updates as presented. Motion passed.

5. Presentation on HUD Section 3 and Fair Housing goals of the CDBG Program

Mrs. Dorthy Jackson made a presentation on the HUD Section 3 and Fair Housing goals of the Community Development Block Grant program. Mrs. Jackson noted the Texas Department of Agriculture, in response to HUD's requirement of facilitating general employment opportunity information for Section 3 Workers, is requiring that all grant recipients that receive TxCDBG funding provide information about the program in an open meeting of the organization. HOTCOG receives grant funding from the TxCDBG program as technical assistance to the Region.

## 1. Department of Administration

a. Financial and Personnel Reports
 Mr. Minnix presented the Financial and Personnel reports to the committee for review.

## 2. Health & Human Services

a. Department Activities Report

Ms. Donnis Cowan presented the Health and Human Services report of activities to the committee for review. Ms. Cowan noted that recently HOTCOG staff met together in Falls County with about 25 other different agencies with similar services, representing every county, to discuss and gain an understanding of different ways to reach people that need services in the community.

## b. HOT Rural Transit District Report

Mr. Devorsky presented the HOT Rural Transit District activities and noted that four new buses have been received and are currently being prepared for service.

## 3. Regional Services

a. Department Activities Report

Mr. Wayne Stovall gave an update on the Homeland Security/Emergency Preparedness program activities. Mr. Stovall noted staff had been notified this week by the Office of the Governor that HOTCOG should receive an allocation of \$471,851.00 for the eight projects that were approved in February and in addition \$40,482.00 was allocated for the Bomb Awareness program. Total conditional allocation from the state for homeland security grants totals \$512,333.00.

Mrs. Dorthy Jackson gave a report on economic and community development activities. Mrs. Jackson provided additional information in the report regarding public works and what EDA will fund for a community. Also, updates were given on the TSTC renovation of building space and the Fairfield project for roadway improvements.

## 4. Executive Director's Report

-Mr. Russell Devorsky noted that staff attended the South West Regional Economic Development Administration (SWREDA) conference May 2<sup>nd</sup>. -Mr. Devorsky stated that Councilmember Jim Holmes was currently serving as the Secretary for the TARC Board.

It was determined that a Quorum was present for the meeting.

II. Proof of posting of notice in accordance with Chapter 551, Texas Government Code, as amended, known as the Texas Open Meetings Act.

Proof of posting of the June 15, 2023 Executive Committee meeting was provided.

- III. Introduction of Guests No guests attended.
- III. Consideration of and/or action on the following:
  - A. New Business
    - 1. Area Agency on Aging FY2024 FY2026 Area Plan Approval

Mr. Russell Devorsky presented the Area Agency on Aging FY2024 – FY20026 Area Plan for approval. Mr. Devorsky noted that the Section 306 of the Older Americans Act, as amended 2020, requires each Area Agency on Aging (AAA) to prepare an area plan for a planning and service area (PSA) for a three-year period, as determined by the Texas Health and Human Services Commission (HHSC). The current HHSC area plan cycle is scheduled for Federal Fiscal Year October 1, 2023, through Federal Fiscal Year September 30, 2026.

Mr. Devorsky stated the area plan is a document that describes, in detail, the identified needs within our PSA and how the AAA plans to address these needs through the development and/or expansion of new and existing community services, along with the added expansion of rural partnerships. The area plan describes our service delivery model within our PSA and provides information on service priorities and targeted outreach to vulnerable older individuals. It identifies the goals and objectives that the AAA's staff, volunteers, and partners plan to accomplish during the planning period. All AAA services mentioned in the plan are dependent on funding and approval from HHSC.

The approval process by HHSC will take up to 6 months with opportunities for plan revisions.

A motion was made by Hill County Judge Justin Lewis and seconded by Falls County Commissioner Nita Wuebker to support and approve the submission of the 2024-2026 Area Plan due on July 31, 2023. Motion passed.

2. Authorization of transfer of HOTCOG owned box trailer to Waco-McLennan County Office of Emergency Management

Mr. Devorsky stated that HOTCOG currently owns a 2009 Cargo boxed trailer approximately 24 ft in length. This trailer has been recently used for the Citizens Community Preparedness (CCP) program to support the COG sponsored CCP program. In the past, HOTCOG was awarded a smaller boxed trailer that is now used for this program. This trailer 2009 trailer was originally owned by Freestone County and transferred to HOTCOG.

Mr. Devorsky noted that the Waco-McLennan County OEM desires to use this trailer to store and deliver supplies needed for the shelter program for the Waco-McLennan County OEM. This appears to be a good use of this trailer.

A motion was made by Commissioner Nita Wuebker and seconded by Judge Justin Lewis to approve the transfer of a 2009 Cargo boxed trailer VN 16131140916102229 to be transferred from HOTCOG to the Waco-McLennan County Office of Emergency Management. Motion passed.

**SUBJECT**: Update to HOTCOG Procurement Manual

## **INFORMATION:**

Based on a recent review of HOTCOG's procurement manual, the Texas Department of Transportation pointed out that the "Non-Competitive Micro-Purchase" threshold of \$3,500 needs to be \$3,000 as referenced in the Texas Grant Management Standards and the Texas Administrative Code. HOTCOG will change all references of \$3,500 to \$3,000.

## **RECOMMENDED ACTION:**

It is recommended that the Heart of Texas Council of Governments Executive Committee, after reviewing the above information, approve the change of \$3,000 for the threshold of "Non-Competitive Micro-Purchases" and update the procurement manual accordingly.

"Historically Underutilized Business" ("HUB") A corporation formed for the purpose of making a profit in which at least 51 percent of all classes of the shares of stock or other equitable securities is owned by one or more persons who are socially disadvantaged because of their identification as members of certain groups, including black Americans, Hispanic Americans, women, Asian Pacific Americans, and American Indians, who have suffered the effects of discriminatory practices or similar insidious circumstances over which they have no control; a sole proprietorship formed for the purpose of making a profit that is 100 percent owned, operated and controlled by a person described in Paragraph (A):

- a partnership formed for the purpose of making a profit in which 51 percent of the assets and interest in the partnership is owned by one or more persons described by Paragraph (A). Those persons must have proportionate interest in the control, operation, and management of the partnership's affairs;
- a joint venture in which each entity in the joint venture is a historically underutilized business under this subdivision; or
- a supplier contract between a historically underutilized business and a prime contractor under which the historically underutilized business is directly involved in the manufacture or distribution of supplies or materials or otherwise warehouses and ships supplies.

"Inter-local Contract/Agreement" An agreement between HOTCOG and an eligible participating government under the Inter-local Cooperation Act, V.T.C.A. Government Code Chapter 791, by which the parties agree to jointly perform procurement functions.

"Invitation to Bid" ("ITB") All documents, whether attached or incorporated by reference, utilized in soliciting competitive or multi-step sealed bids.

"Micro-Purchase" A purchase of supplies or services using simplified acquisition procedures, the aggregate amount of which does not exceed the micro-purchase threshold of \$3,000.00 in order to expedite the completion of its lowest-dollar small purchase transactions to minimize the associated administrative burden and cost. The micro-purchase threshold is set by the Texas Grant Management Standards and the Administrative Code.

"Minority Business Enterprise" ("MBE") A small business concern wherein at least 51% is owned or controlled in management and daily operations by women or minorities, including, but not limited to, "blacks, Hispanics, Asian-Americans, American Indians and Alaskan natives."

"Negotiated Procurement" A process similar to the competitive sealed bidding procurements except that offerors and HOTCOG discuss or negotiate aspects of the proposal, such as price. Negotiations are held with all offerors in the competitive range, in the order of ranking, based upon the evaluation factors set out in the RFP.

"Offeror" A person that submits a proposal in response to a Request for Proposal (RFP).

## 2.4 Authorization of Purchases

The Purchase Requisition should contain the following approvals to correspond to the total cost:

- Program Management, Department Head and the Director of Administration for all purchases of \$.01 to \$3,000.00
- Program Management, Department Head and the Executive Director or designee for all purchases of \$3,000.01 to \$49,999.99
- The Executive Committee for all purchases of \$50,000 and above

## 2.5 Pre-commitment Documents

Pre-commitment documents are purchase requisitions and contract action notices, Interlocal agreements, and are used to initiate procurement transactions. These documents provide a system of authorization and documentation, and should contain the following information:

- date of request;
- department, including contact person;
- date required;
- quantity;
- description of goods and/or services requested;
- authorized signature(s);
- actual or estimated cost;
- project code(s); and
- delivery destination.

## 2.6 Procurement Instrument

Procurement instruments include Purchase Requisitions and Purchase Orders, Interlocal agreements, or contracts. Each procurement instrument must contain the approval of the Director of Administration, Department Head and if applicable, the Executive Director, which will certify that the purchase satisfies the appropriate bid procedures and applicable grant requirements or restrictions, that adequate funds have been authorized and that appropriate approval(s) have been granted. Purchase Orders are only issued by the Director of Administration.

## 2.7 Monitoring of Programs

Department Heads and the Director of Administration shall have the responsibility to monitor grant, sub grant funded programs, and all procurements. The monitoring system shall:

 ensure adherence to the system established for the award and monitoring of contracts;

## **ARTICLE III**

#### PURCHASES OF \$50,000.00 and UNDER

## **PART A: Non-Competitive and Competitive Purchases**

- 3.0 A non-competitive purchase is defined as the procurement of supplies, equipment, services, or other property, that does not cost more than \$50,000 in the aggregate. If the expenditure for a purchase is for less than \$50,000 ("bid limit"), HOTCOG may proceed in one of three ways:
  - Non-Competitive Micro-Purchase If the price is less than \$3,000.00, the purchase may be made on a non-competitive basis, meaning that only one (1) written price quotation is required, but three (3) quotes may be required at the discretion of the Executive Director for purchases over \$1,000. The selection of the supplier can be made to the convenience of the department without contacting additional suppliers; however, purchases must be distributed evenly among qualified suppliers.
  - **Competitive Small Purchase** If the price is more than \$3,000.00, but less than \$50,000.00, price quotations should be solicited from three (3) or more qualified contractors/suppliers to ensure the price is fair and in line with the current market. The quotation must be in writing and can be obtained via mail, fax, or e-mail. The Department Heads may negotiate the price as appropriate, or source for additional suppliers, as required.
  - \$50,000, HOTCOG may still ask for a sealed bid. This approach gives several advantages, for example, if later purchases cause the total purchase price to exceed the bid limit, the competitive bidding requirement is satisfied. Provisions allowing later purchases on the same terms might be written into the original contract. In addition, bids may be more competitive with a sealed bid. And lastly, conflicts of interest between contractor or supplier and the procuring department are minimized.

Purchases may <u>not</u> be split to circumvent the competitive requirements or the bid limit.

- 3.1 Selecting the Supplier/Contractor and Making the Purchase
  - After price quotations are obtained for purchases below the bid limit, the procuring department selects a supplier/contractor and makes the purchase. The supplier with the lowest and best offer meeting the price expectation, reliability, and quality of the product should be used as a basis for selecting the supplier.

WHEREAS, the governing body of the Heart of Texas Council of Governments has reviewed this application and authorizes its submittal to the Texas Commission on Environmental Quality; and

WHEREAS, the governing body of the Heart of Texas Council of Governments finds that all activities and related expenses included in this application will serve to implement the goals, objectives, and recommendations of the regional solid waste management plan and the state solid waste management plan; and

WHEREAS, the Heart of Texas Council of Governments will comply with the financial and program reporting requirements of the Texas Commission on Environmental Quality and the State of Texas; and

WHEREAS, grant funds will be used only for the purposes for which they are provided;

THEREFORE BE IT RESOLVED BY THE EXECUTIVE COMMITTEE OF THE HEART OF TEXAS COUNCIL OF GOVERNMENTS THAT the solid waste grant program application as submitted is approved and hereby submitted to the Texas Commission of Environmental Quality, Waste Permits Division.

**SUBJECT:** Authorizing approval of 9-1-1 expenditures for AT&T monthly recurring network, equipment maintenance and software support costs

## **INFORMATION:**

HOTCOG 911 staff is requesting authorization to approve expenditures of \$95,616 for the pre-payment of two years of maintenance costs of the 9-1-1 equipment at the 6 regional Public Safety Answering Points (PSAPs). It is vital the 9-1-1 equipment be maintained 24 x 7 from appropriate vendors and pre-payment out of FY 2023 funds is the only way to assure service can be continued. Authorization to approve expenditures of \$79,417 for a 24-month term to maintain the secondary, diverse network in place to sustain 9-1-1 services in the event of an outage to the primary 9-1-1 network is also included in this request as well as expenditures of \$107,338 for renewal of software support for a 24-month term. Please note that these purchases are through HGAC cooperative purchasing agreements #EC07-23 and DIR-TEX-AN-NG.

## **ACTION**:

Staff recommends that the Heart of Texas Council of Governments' Executive Committee approve the authorization for the Executive Director to sign service agreements with AT&T for monthly recurring network and maintenance cost expenditures totaling \$282,371.

### HEALTH AND HUMAN SERVICES PROGRAM DESCRIPTION AND ACTIVITY

The Health and Human Services Division (HHS) is one of two divisions of the Heart of Texas Council of Governments. The HHS division is made up of four different and distinct program areas 1) Area Agency on Aging; 2) Aging and Disability Resource Center; 3) Heart 2-1-1; and 4) Rural Transit District which primarily serve and work with individuals and family members who need assistance through either information or services. Below are the four program descriptions and activities.

### 1. Heart of Texas Area Agency on Aging (AAA)

- > Serves six counties including Bosque, Falls, Freestone, Hill, Limestone and McLennan.
- Provides access to needed social services, effective screening and assessment of individual needs, and advocacy for older persons (age 60 and older), their family members or other caregivers.
- > Directly administers services including benefits counseling, care coordination, caregiver support coordination, and long-term care ombudsman services.
- Contracts with service providers throughout the region to provide nutrition (congregate and home delivered meals), homemaker care, respite care, personal assistance, minor home repairs, health education classes and caregiver counseling to caregivers and their loved ones.
- All programs are operated in accordance with all policies and procedures.
- We have two vacant positions 1) Managing Local Ombudsman, and 2) Contract Quality Assurance Specialist. Second interviews are being conducted for both positions.

## 3. Heart of Texas Area Information Center (AIC) - (HT 2-1-1)

The 2-1-1 program is a nationwide "free" social service phone helpline answered by highly trained call specialists who listen to the caller's needs and provide resources and information for the caller to evaluate and make the choice as to which referral sources best fit their needs. The caller can then reach out to the resources that best fit their needs at any time. It is the caller's responsibility to reach out to each agency and provide any additional information requested for consideration for assistance through their program. 2-1-1 does not provide any direct funding, only referrals to non-profit, social services agencies who have voluntarily become part of our database designed to assist our callers. Callers are always encouraged to call back to 2-1-1 at any time should they need more resources or identify another need.

- 2-1-1 provides referral information about health and human services to all callers regardless of age, ethnicity, gender, disability, or any other criteria.
- 2-1-1 is available 365 days a year and 24 hours a day.

HOT 2-1-1 (HT) continues to take traditional calls for local social service needs including food pantries, utility bills, rent, childcare, and medication assistance plus mental health and everything from A-Z for the state of Texas including the six-county service area. In addition, we take disaster-related calls when such an event occurs and provide close monitoring and reporting of any resources available for those impacted by the disaster.

- For the months of May July 7,884 calls came into the six-county service area. There were 1931 referral calls taken where information was provided to the caller regarding resources to meet their needs. The call specialists try to find at least 3 referral sources for each identified need. There is no limit to the time of each call, or the number of needs discussed. Our goal is to provide as many resources as the caller needs.
- For the months of May July 3,488 calls were transferred by the 2-1-1 Call Specialist to option 2, Your Texas Benefits. Once the call is transferred the caller is connected to a representative from Health & Human Services Commission for assistance with their Medicaid, SNAP - Food Stamp Benefits, CHIP, and Medicare Savings Program.

Houston-Galveston 2-1-1 and routed afterhours AICs <u>answered and provided information</u> to our Heart of Texas after hour and weekend callers:

- The average number of calls handled each month by Houston-Galveston 2-1-1 between May – July was 208 calls.
- This represents an average number of calls during the week of 324 and on the weekend 237.



### REGIIONAL SERVICES REPORT

### June-August 2023

### 9-1-1

### HOTCOG 9-1-1 IP Network (Next-Generation 9-1-1)

Members of the TriCOG 9-1-1 Alliance (BVCOG, CTCOG and HOTCOG) continue to collaborate with network consultants and equipment vendors to maintain a robust network. The TriCOG Alliance renewed its partnership with Mission Critical Partners (MCP) for NextGen Core Services (NGCS) Consulting and Cybersecurity Support. MCP will follow a new scope of work that was provided to the TriCOG identifying three tasks to assist the TriCOG in technical issues to include Project/Task Management for GIS Readiness and Geospatial Call Routing, Procurement support for a Request for Proposal for call handling equipment and the development of a Cyber Security Plan. Members of the TriCOG participate in regularly scheduled conference calls to discuss NGCS projects and planning for the future of the regional networks.

On November 29, 2022, the final Originating Service Provider (OSP) in the HOTCOG Region migrated their 9-1-1 traffic from legacy selective routers that are slowly being decommissioned. Since December 15<sup>th</sup>, there has been no 9-1-1 traffic on those legacy circuits, meaning all HOTCOG Public Safety Answering Points (PSAPs) are routing 9-1-1 traffic via the VESTA router. Disconnect orders for the legacy circuits provided through AT&T were submitted on May 15, 2023. Other service provider disconnect orders will be submitted as well. Project planning calls with Motorola Solutions Connectivity, Inc. continue to be held weekly, and discussions include ongoing project deliverables and discussions for upcoming activities.

During the week of April 10<sup>th</sup>, HOTCOG staff worked with Motorola team members and PSAP personnel to onboard and test Text-to-9-1-1 via the ESInet. Text traffic will no longer be delivered via legacy circuits as it had been since initial deployment. The Hillsboro Police Department was the first in the state to receive a 9-1-1 text via the ESInet. All PSAPs in the HOTCOG Region were onboarded, tested, and now have this functionality available.

### Enterprise Geospatial Database Management System (EGDMS)

In NG9-1-1 systems, an EGDMS (GIS map data) replaces the traditional Master Street Address Guide (MSAG) for location-based 9-1-1 call routing and location validation. An EGDMS is crucial for the transition to NG9-1-1 because it provides a means to create and maintain data critical to NG9-1-1 success. Staff participated in the Customer Focus Group (CFG) for this project. The CFG was responsible for assisting with development of the Quality Assurance/Quality Control plan, participating in GIS Data Management collaboration meetings, and assisting in GIS data management workflow development.

9-1-1 staff exceeded the 99% data match rate as recommended by the National Emergency Number Association (NENA) with a match rate of 99.99% with no critical errors remaining. HOTCOG has completed the transition to an EGDMS, and staff is a participant in a focus group for continued implementation across the state.

### Text-to-9-1-1

Text-to-9-1-1 is available in the HOTCOG Region as an alternate means of communicating with 9-1-1 for people with a hearing and/or speech disability, or when speaking aloud would put the individual in danger. Text-to-9-1-1 also provides a silent alternative in cases such as child abduction, active shooter, or domestic abuse.

# Homeland Security/Emergency Preparedness

### **Grant/COG Projects**

- Staff attended the monthly Homeland Security conference calls with the Office of the Governor (OOG).
- Staff completed the transfer of two communications towers, 1 to McLennan County and 1 to the City of Marlin which were built with State Radion Infrastructure Funds.

- Staff also transferred ownership of a 2009 cargo trailer previously used by the Citizens Corp Grant, to the Waco-McLennan County Office of Emergency Management for their use to provide equipment for warming and cooling shelters in the area.
- HS and CJ staff attended Response to Bombing Incidents Training in Socorro, NM as part of the Bomb Materials Awareness Grant and began conducting outreach to the local communities and businesses to provide training for this program.

### **Technical Assistance**

HS conducted training in Intermediate and Advanced Incident Command for local first responders.

Staff met with officials from Falls, Bosque, and Hill Counties to provide additional training on the use of the HOTCOG Regional Notification System.

Andy Davis was hired for the position of Emergency Preparedness Planner.

### **Criminal Justice**

### **Planning Grant**

CJ Planner, Lana Gudgel, continues to work with the new Heart of Texas Regional SART and the McLennan County SART and has completed the mandated protocols and bylaws for both teams.

CJ Planner has completed the Falls County Community Plans and has updated the Heart of Texas Regional Strategic Plan.

### **BMAP**

In FY 2022, HOTCOG was awarded the Homeland Security BAMP grant. Criminal Justice Planner Lana Gudgel and Manager Wayne Stovall attended the updated Incident Response to Terrorist Bombing Train the Trainer in Socorro, NM in July 2023.

CJ Planner, Lana Gudgel, and Program Manager, Wayne Stovall began visiting retail stores in the Waco area that sell chemicals and other items that can be used to make homemade explosive devices. Lana and Wayne explained the BMAP to the managers and owners of 15 area stores and offer free training for store employees.

### Regional Law Enforcement Training Academy Grant

The new cycle for FY 2023 began on October 1, 2022. Since the start of the new cycle, 195 officers and telecommunicators have attended Law Enforcement Training Classes for a total of 4228 contact hours. CJ Planner taught the Basic Instructor Course in McLennan County and Limestone County 16 officers/deputies successfully completed the course. The end of the TCOLE training cycle is August 31, 2023. In preparation for the end of the cycle, Criminal Justice Planner Lana Gudgel has scheduled the Telecommunicators 786 Cardiac Emergency

Communications, TCIC/NCIC Full Access, Juvenile Law and Procedures, and the Crisis Intervention Refresher 3843 for August 2023. The registration training software for the Law Enforcement training program has registered 477 officers since October 2021. The training program has collected \$6279.00 in out-of-region fees to date.

One hundred (195) students attended HOTCOG training, totaling 4228 contact training hours since October 2022.

### Economic & Community Development Department Staff Report

### REVOLVING LOAN FUND

HOTEDD currently administers two revolving loan funds: One through USDA (United States Department of Agriculture) and one through TDA (Texas Department of Agriculture).

The USDA fund is to support our local businesses so that they can grow, create jobs, and diversify our regional economy. Specifically, the HOTEDD RBEG RLF Program seeks to assist qualified small and emerging businesses in the rural Heart of Texas including Bosque, Falls, Freestone, Hill, Limestone, and rural McLennan Counties. Any private business that will employ 50 or fewer new employees and has less than \$1 million in projected gross revenues located in the rural (as defined by USDA) Heart of Texas region including Bosque, Falls, Freestone, Hill, Limestone and rural McLennan Counties (McLennan County communities that are not contiguous to the City of Waco). On a case by case basis, the Loan Committee may waive this requirement and provide loan funds to a business located outside the region if the committee determines doing so will have a positive economic impact on the community to be assisted with RLF funds. The project will create or retain one full-time job per each \$10,000.00 in loan funding. At least 51 percent of the interest in the business (applicant) must be owned by those who are either citizens of the United States or reside in the United States after being legally admitted for permanent residence certifiable by HOTEDD and USDA. HOTEDD RLF's financial assistance is necessary to the viability of the project: There must be evidence presented by the applicant that demonstrates that the projects financial requirements cannot be met from owner resources or a commercial financial institution.

Texas CDBG funds provided under the TCF SMRF program are required to comply with the national objective of principally benefiting persons of low and moderate income. The objective of the program is to expand economic opportunities that create or retain jobs, principally for low- and moderate-income persons. The SMRF program provides resources for an eligible applicant to support qualified small and microenterprise business(es) (a for-profit entity) to create or retain jobs for Texans. The CDBG regulations provide the following definitions: **Microenterprise Definition**, A "microenterprise" is a commercial enterprise that has five or fewer employees, one or more of whom owns the enterprise. "Persons developing microenterprises" means persons who have expressed interests in and who are, or after an initial screening process are expected to be, actively working toward developing businesses, each of which is expected to be a microenterprise at the time it is formed. 24 CFR §570.201(o)(3): **Small Enterprise Definition** is an enterprise" or "small business" is a commercial enterprise that has 25 or fewer employees, one or more of whom owns the enterprise. Falls County is the only county under the SMRF fund. The funding period through TDA and regulations is over but once TDA closes out the

contract with Falls County then HOTEDD can lend the revolving funds back into Falls County without the stricter requirements of TDA. At this time Falls County has not received closeout information.

HOTEDD is currently seeking applicants for approximately \$247,341 in USDA revolved funds.

The Public Works program provides resources to meet the construction and/or infrastructure design needs of communities to enable them to become more economically competitive. Examples of projects that have been funded previously include, but are not limited to:

- acquisition and development of land and improvements for use in public works or other types of development facilities;
- design and engineering, construction, rehabilitation, alteration, expansion, or improvement of public works, public service, or related development facilities, including related machinery and equipment;
- water and sewer system improvements;
- creation or expansion of industrial parks;
- creation or expansion of business incubator and accelerator facilities;
- expansion of port and harbor facilities;
- construction or expansion of facilities for workforce development;
- redevelopment of brownfield sites;
- expansion, construction, or improvements of technology-based facilities and research and development commercialization centers, including the procurement of necessary equipment;
- construction, expansion, or improvement of wet labs, including the procurement of necessary equipment;
- construction of multi-tenant manufacturing facilities;
- expansion or improvement of research, business and science parks; and
- expansion or enhancement of public facilities with higher quality fiber optic cables and telecommunications infrastructure and broadband infrastructure deployment.

### **Economic Adjustment Assistance (EAA)**

Through the EAA program, EDA provides investments that support a wide range of construction and non-construction activities in regions experiencing adverse economic changes that may occur suddenly or over time. Supported activities include construction and non-construction such as sectoral partnerships for workforce training, design and engineering, technical assistance, economic recovery strategies, and capitalization or re-capitalization of Revolving Loan Funds (RLF). EDA utilizes EAA investments to provide resources that help communities experiencing or anticipating economic dislocations to plan and implement specific solutions to leverage their existing regional economic advantages to support economic development and job creation. Like Public Works investments, EAA investments are designed to help communities catalyze public-private partnerships to foster collaboration, attract investment, create jobs, and foster economic resiliency and prosperity. Examples of projects that have been funded previously include, but are not limited to:

- · construction or upgrading of public infrastructure;
- design and implementation of sectoral partnerships (see section 3.a.);
- activities necessary to strengthen cluster acceleration and expansion;
- capitalization or recapitalization of revolving loan funds (RLFs);
- development and implementation of long-term disaster recovery and resiliency plans;
- enhancement of infrastructure to make it more resilient to natural disasters:
- implementation of military base realignments and closures (BRAC) responses;
- development or expansion of commercialization and proof of concept centers;
- procurement of equipment for workforce training programs;
- market or industry research and analysis for larger hard or soft economic projects;
- creation or expansion of foreign direct investment, trade, or export initiatives;
- economic development projects that enhance density in the vicinity of other economic development;
- "strategy grants" to develop, update, or refine a Comprehensive Economic Development Strategy (CEDS) as described in EDA's regulations at 13 C.F.R. § 307.3; and
- development of projects that provide technical assistance to enhance the capacity of key economic development actors in the region to promote the region's locally owned strategies.

### **Current EDA projects Administrated by HOTCOG/HOTEDD:**

<u>TSTC Project through the Cares Act funding</u>: The EDA investment is for the renovation of building space within the 30,877 sq ft Technical Studies Center (TSC) building and 41,223 sq ft Electronics Center (EEC) building. Major components for both buildings include:

- Conduct abatement,
- Conduct demolition,
- Installation of electrical, plumbing and IT infrastructure,
- Renovate interior lab and classroom space,
- Equipment purchase of technology equipment to support on-line lecture distribution The investment is for \$3,500,000 from EDA and original budget for total project was for \$6,083,594.

The TSTC project has moved forward with EDA approving contractor, Imperial Construction, for \$9,050,000. Construction is expected to start in September.

<u>Fairfield project</u>: The EDA investment is for roadway improvements of approximately 3,750 feet of the existing Old Mexia-Fairfield Road (County Road 946). The roadway reconstruction includes upgrading from a variable width (18-20 feet) asphalt concrete paved roadway to a formalized 24-foot-wide concrete paved roadway with stabilized subgrade and base and includes a culvert replacement. Other

components include sitework, traffic control (permanent and temporary), curbing and inlets, driveway approach, erosion control measures and a minor utility relocation.

EDA investment is \$950,000 with total project estimated cost at 1,577,410.

The site certification work has been submitted to EDA after long process of getting easement right of ways. Now we are waiting for EDA to approve the site certificate so that we can move forward with bid process.

### **Training**

Dorthy Jackson and Falen Bohannon attended Annual Brownsfields Conference, August 7-11, that is hosted by EPA and IEDC. Meeting with Region 6 EPA representatives to come to Waco to discuss how we can move forward to help our region identify Brownsfields areas and how they can help fund projects to remediate those areas. Funding is coming out in 2024 that in which is possible for HOTCOG to apply for that can help the region.

### **COMMUNITY DEVELOPMENT**

Staff is forwarding information to the community that comes down from Federal partners on upcoming grants.

Texas State offices are still working remotely.

Dorthy Jackson is continuing to work with the City of Mexia and City of Lacy Lakeview for GLO Grants.

The overview of the GLO grant will be continued in these reports for reference of the Executive Committee Board and HOTEDD Board members.

Dorthy Jackson has been working with the City of Whitney, City of Mexia, Hill County, and City of Clifton on grant through the Texas General Land Office (GLO) who have allocated up to \$100 million in Community Development Block Grant Mitigation (CDBG-MIT) funds for the Resilient Communities Program (RCP). RCP funds the development, adoption, and implementation of resilient building codes, flood damage prevention ordinances, zoning ordinances, comprehensive plans, and land use plans. Additionally, RCP funds an array of public service activities related to resilience. The maximum grant amount is \$300,000 per applicant. HOTCOG will be the grant administrator for the City of Whitney on this grant. The City of Whitney will be eligible for funds up to \$100,000 due to population. Please see Dorthy Jackson if there is an interest in your community to apply for this grant.

Dorthy Jackson provided EDC training to the Marlin EDC board on June 27th.

Dorthy Jackson and Falen Bohannon went back to the City of Teague to provide EDC training to the Teague city council on July 21st.

### TDA (Texas Department of Agriculture)

Dorthy Jackson is sending out notifications of TDA announcements as they come in.

Dorthy Jackson hosted two virtual events on July 13<sup>th</sup> and 20<sup>th</sup>, for newly elected officials and any other official that wanted refresher, for information about Section 3 Fair Housing and about HOTCOG's work in the region.

### Solid Waste

The SWAC determined that FY22 would be COG Managed Projects and FY 23 would be for Implementation Project. Implementation projects have officially been opened. Each entity has returned their signed Interlocal Agreements. All entities are now able to start their projects. The City of Waco and the City of Riesel have already finished their projects and are waiting on reimbursements. Falls County will be conducting their project this month and all other projects are going to be done in June. All projects are to be conducted no later than the last day of June. All projects are expected to be completed and on time.

### **Air Quality**

Staff remains in communication with consulting firm and works directly with them on a variety of issues and questions. Staff makes sure that all correspondence is documented, all invoices have PO's and Reqs attached, and are paid on time. Ramboll selected initial set of high-resolution satellite data imagery scenes of different resolutions for Lake Waco based on cost, day of the week, month, and temperature criteria to determine which products will be useful to estimate the number of pleasure crafts on specific days. Ramboll requested a change to the statement of work to reschedule the LAI field study to April-May 2023 due to drought conditions in the Waco area.
